1	The total number of section of the school shall be restricted to 20. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed. Further increase of section shall be subject to specific approval of the

	Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft.
2	As reported by the school, there are 2 building blocks; however the same is not mentioned in the building safety and fire safety certificates. The school is directed to obtain fresh building safety and fire safety certificates for all 2 blocks and upload the same on SARAS portal within 3 months.
3	The total land area as per land certificate is 8361 sq mt however in the OASIS data, the total land area is 8361 sq mt with playground 10,000 sq mt. Hence the school is directed to apply on SARAS portal for correction of land area.
4	The ramp at the entrance and the ramp to enter into toilets are of temporary arrangement. Hence the school is directed to construct permanent ramp and convenient for CWSN students and submit the video link on SARAS portal within 3 months.
5	The CWSN toilets seen in the RC videography are not sufficient. The school is directed to make separate CWSN toilets for boys and girls on each floor of both the blocks and submit the video link within 3 month on SARAS portal. The school is advised to refer circular No.5/2023 for CWSN facilities.
6	The school shall conduct training of its teachers with CoE Vijaywada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be

- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
